Employees travelling internationally can access EA's Employee Service Center 24 hours a day, 365 days a year, from almost anywhere in the world by calling 855-CNA-4900 (855-262-4900).

Register your international trip through the CNA Canada Travel Assistance online portal to ensure you receive alerts and travel advisories as they are updated by U.S. and Canadian government agencies. Login to the site and use the following credentials to register your travel:
